### Jason Spilkin - Co-Manager

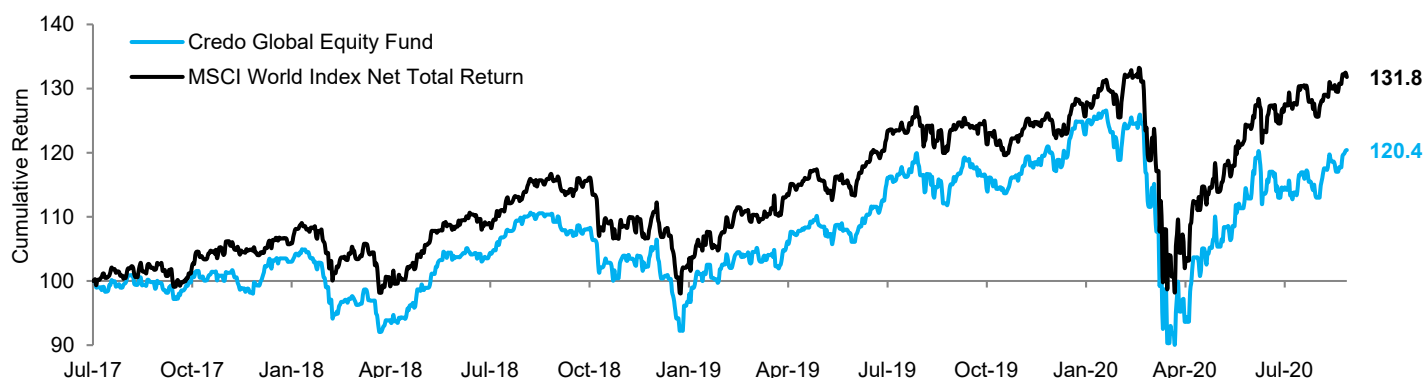

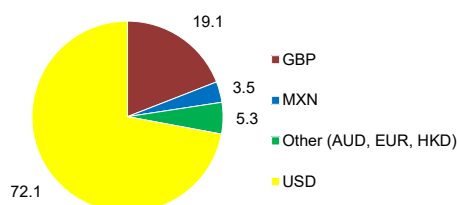

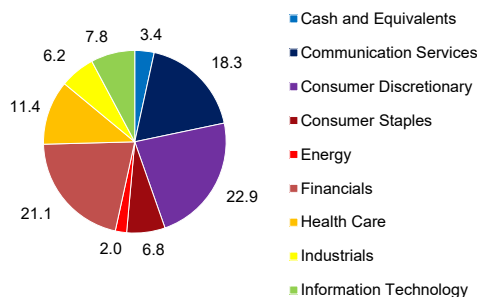

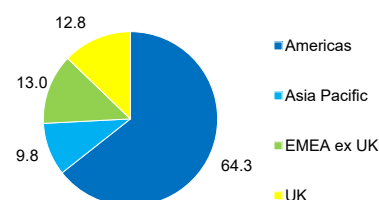
## Currency Allocation (%)
