

INVESTMENT OBJECTIVE

The BCI Credo Global Equity Fund's objective is to generate sustainable excess returns versus global equity market indices through an actively managed portfolio of equities from issuers across global equity markets.

INVESTMENT POLICY

The portfolio will, apart from assets in liquid form, invest solely in the participatory interests of the Credo Global Equity Fund, a sub-fund of Credo ICAV, domiciled in Ireland. The underlying portfolio invests primarily in global equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act. The fund can only invest in Credo Global Equity Fund. Minimum 80% foreign exposure.

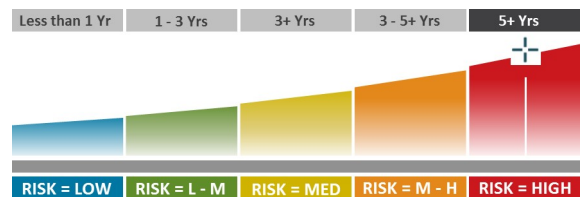

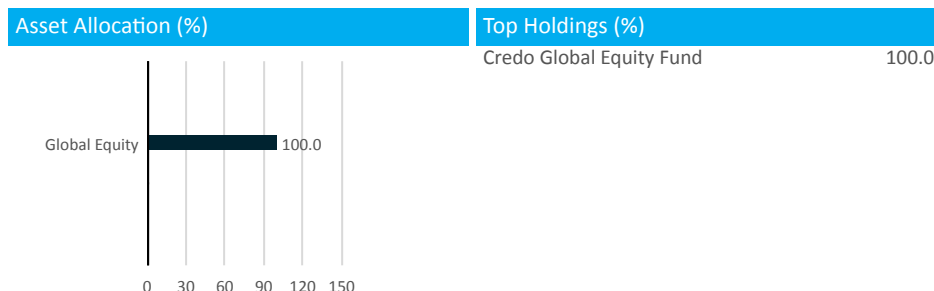
RISK PROFILE



High Risk

- This portfolio has a higher exposure to equities than any other risk profiled portfolio and therefore tends to carry higher volatility due to high exposure to equity markets.
